

Dear Commission into Domestic Violence,

Please consider the following events in your analysis of domestic violence and child sex abuse in South Australia.

In [redacted] after and just before reporting child sexual abuse I was threatened with a hit man by ex husband (the perp), had petrol poured around my house, my young children (A, B, and C) were threatened with my murder, told I was going to have my head cut off and my body would be put in a bin.

The perp [redacted] OL and Child Protection Services that he enjoyed viewing [redacted] child sex abuse material. This is written in a CPS Report [redacted]. Despite this admission [redacted] has never been charged, searched or prevented from teaching a [redacted] schools for [redacted] still employed a [redacted] and the current [redacted] have chosen not to [redacted]

SAPOL, Families SA and CPS all received evidence of A and B displaying highly sexualised behaviour at ages 3 and 4 on CCTV footage where Experts such as Professor Freda Briggs and Senior Psychiatrist [redacted] it was clear the boys had been sexually abused by [redacted]

[redacted] records state it was reasonable to suspect one or both boys sexually abused but they lacked the staff and resources to investigate the case so Families SA closed the case. [redacted] ly Court Judge to hand the children over to the [redacted]

The children were in the full time care of the perp from [redacted] until [redacted] when A and B left his home and came to live with [redacted] child [redacted] all lives with the perp and attends [redacted]

While the children were living with the perp they disclosed being raped, bashed and psychosexual abuse and constant threats of being killed and having their [redacted]

In [redacted], the perp instructed the children A, B and C to pass on the death threats about me to my youngest child D, who was only 4 years old at the time. Child D became very traumatised, setting up barricades around the house so the perp couldn't kill him, his dog or me. All 4 children informed me they had [redacted] g to kill me by stabbing me in the face and [redacted] when I was asleep and setting it on fire. [redacted] cidal.

I reported all events above to SAPOL, Child Abuse Report Line and Families SA [redacted]. The only response I got was constant psychiatric assessments [redacted] of me, organised by SAPOL and Families SA. All psychiatric assessments stated there was nothing wrong with me and my account of the child sexual abuse and DV was strikingly plausible. At no stage in the last [redacted] years has the perp ever been independently psychiatrically assessed [redacted].

Due to the ongoing death threats and trauma to all 4 children I had no choice but to stop contact with my children A, B, and C. (The only way I was allowed to see A, B and C was if I had the perp in my home with all 4

children and me). I was very fearful he would actually harm one or all of us.

After I stopped the contact the perp used my family members to pass on threats. He told my mother to tell me if I made any more reports about the abuse of A,B and C es SA would take child D away from me. My father, on [REDACTED] threatened to [REDACTED]

With no support and [REDACTED] nstant threats, I pack [REDACTED] r, and child D and Myself drove to [REDACTED] (June 2015). Once in [REDACTED] I asked the family court to return [REDACTED] ildren A,B and C to my [REDACTED] they didn't listen or care. Child A called me stating he was being bashed constantly and he wanted to kill himself. I was desperate to help the children so I started a petition on change.org. I had asked every organisation in the country for help and every one said 'it was not their jurisdiction', so I made it my jurisdiction to keep child A alive and try to protect the other children and myself from further abuse and threats.

In response to pleas from Child A [REDACTED] o [REDACTED] o [REDACTED] r 2015 [REDACTED] ortly afterwards detective [REDACTED], [REDACTED] [REDACTED] had told me 'was a liar', [REDACTED] n front [REDACTED] d [REDACTED] cause [REDACTED] d 'he was concerned about the [perp's] mental health'. I told detective Power I was more concerned about the children's mental health.

Sapol have told me I'm not allowed to write about this case or mention the children's or perp's name or they will lock me up and throw away the key.

When Child A and B came to live with me and child D in mid 2019 they disclosed [REDACTED] d spiritual abuse by [REDACTED]. The perp [REDACTED] n at their [REDACTED]

[REDACTED] ent to poli [REDACTED] and Child B even wrote to the PM [REDACTED] Detective [REDACTED] refused to let child B have a [REDACTED] l examinati [REDACTED] eing repeatedly raped as a child and Detective [REDACTED] said it was unnecessary to search the perps home and threatened [REDACTED] ake a complaint about me If we raised the issue again.

PM [REDACTED] wrote back to Child B stating the case was the Jur [REDACTED] hen Premier Steven Marshall, who did nothing, just as Premiers Malinauskus and Weatherill before him did nothing.

Child A became increasingly depressed and suicidal over the last 4 years and began blaming me for his abuse as a child calling me 'the dumb bitch stupid enough to marry a paedophile'. I tried everything to get [REDACTED] A [REDACTED] POL and Mental Health at [REDACTED]. After watching Child A [REDACTED] he could die, I got the money together to send him [REDACTED] where he is now living with his best friend

and getting much better mental health support compared to what he received here.

Child C who is still living with the perp has been told if she stays loyal to the perp and paternal grandparents she will inherit their millions. She told child B 'she has to think of her financial future'.

Child D is still traumatised by events in his early childhood and recently made a report to SAPOL with the help of [REDACTED], who are supporting him [REDACTED]

[REDACTED]

[REDACTED] as a result of my children being abused and then handed over to the abuser and the ongoing death threats directed at me and my children for the better part of 16 years.

I still have nightmares about the abuse and threats. I still live in fear.

The problem with the 'system' in SA is that the perp in this case should have been charged in [REDACTED] when he admitted to viewing underage child sex abuse material. SAPOL, Families SA and CPS have all failed drastically and the civil family court has no jurisdiction to investigate or decide upon criminal matters such as child sexual abuse and DV.

The major concern is the trauma my children and I still have to live with everyday and the risk to every child the perp has access to as a current school teacher. The boys A and B who are now, [REDACTED] old told me the perp looks at the photos of all the students he gets each year to work out which ones he thinks are 'hot'. There should have been a thorough search of his property and his parents by now.

I hope whoever reads this can take appropriate action. All records have been securely kept in multiple places across the country.
