## ██████ timeline for Facebook

██████ called through and saw ██████ last year and made me aware that there were problems between ██████ and ██████.

██████ – 2023 ██████ rang me at 8:49 AM we spoke 41 minutes 35 seconds, ██████ was quite upset, saying that everywhere she goes ██████ tells everyone that she has full-blown dementia and he is her carer.

██████ – 2023 after talking to ██████, I thought I would ring back and talk to ██████ again, asking her how we could help her. ██████ explained ██████ had taken her to the bank and coherced/forced her to sign over her life savings of \$100,000 to his super fund.

██████ started this account when she first left school and was working for ██████ at ██████, **it held the money from her share of our mother's estate**, as well as money earned through her investments.

██████ said what worried her was that ██████ hung around the house the next day, and took call from the bank asking if it was all good to go ahead and transfer the \$100,000, and ██████ said its all good, he never let ██████ speak to the bank manager.

**██████ was quite distraught on the phone at having lost her life savings.**

██████ said ██████ at hung around the house the next day and when the bank rang he said to go ahead with the transfer.

██████ said to 3 days later she rang the bank, and asked about stopping the transfer, they said it was too late.

██████ – 2024 I rang ██████, she said I'll ring you back when it is clear that I can speak.

██████ – 2024 ██████ rang and she said she was still concerned about being forced to hand over a \$100,000.

██████ said that the last time she had been to the ██████ farm, there was a four-bedroom house all with ensuite and that had the walls and the roof on it up to the lock-up stage. The farm originally had three houses on it; the original stone one had been knocked down, another Stonehouse and a housing trust type prefab which her in-laws ██████ had lived in as well ██████ and their 4 girls.

██████ felt the farm was bankrupt and the \$100,000 was to go to ██████ her daughter and son-in-law, she felt it was a lost cause, the bank would grab the \$100,000 and they would still lose the farm.

██████ works in a government job, travels to ██████ and ██████ is left there on the farm with their ██████ daughters.

█████ said that the two daughters were booked into █████ and if the farm went bankrupt she couldn't see how they could pay for them to go to it, one would start then the next year the second one would start, meaning an overlap one year at double costs.

█████ said they had properties, █████ north of █████ and a house in █████, which were bought and set up as superannuation properties under the █████ trust..

█████ said that █████ had taken the book work from her and given it to █████ who was a city accountant and █████ felt she did not have the training/expertise to handle the conveyance of these properties to █████. If this was not done correctly █████ **felt that she could be charged** and held accountable as she helped set these superannuation trusts up.

█████ husband █████ as also forbidden █████ to come to their house.

I explained to █████, █████ has transferred the running of your █████ Trust operations and █████, she's one who will go to jail not you.

█████ explained that █████ had taken over the running of █████ affairs, █████ a ward of the state and lives in Adelaide in shared accommodation, this happened when █████ was in hospital having 18 inches of bowel removed, █████ would not look after █████, he cohersed/made █████ sign █████ over to ward of the state.

█████ explained that █████ after █████ last visit to █████ **"he never wanted to see █████ in his house again"**. On that last visit █████ had yelled/screamed at █████, next thing █████ saw █████ leave the house, walk to the road and head towards █████, █████ followed up to the top of the first rise and █████ was nearly up the next rise, the █████ then ran back to the house and got the car and followed █████.

When she caught up with █████ █████ said hop in and I'll take you to █████, █████ said I did left turn, left turn, left turn then we were home, so █████ said to █████ we are home, would you like to come in and have a cuppa tea and █████ said yes.

█████ also said that █████ had been banned by █████ and wasn't to come to the house again, I take it is through the fact that █████ and █████ who have bought the █████ farm and are possibly going bankrupt.

█████ comes from around █████, he was only ever a farm worker, he never worked in any management role, and █████ said once █████ and █████ bought the farm they bought new tractors and farm implements on time payment.

█████ said whenever █████ around, and he sees █████ he turns his back, he is very surly.

██████ was a very good manager, she told me that when ██████████ wanted to buy a new tractor, he had to sell an old one, and had to wait until they were paid for before any more were bought.

██████████, when they were at ████████, was the president of the ████████ Hospital board, and was quite often very late getting home from the meetings.

██████ told me the story that when ██████████ was away at ████████ Hospital board meeting work and she was driving the tractor for seeding and next thing one of the ██████████ boys stopped and come across the paddock to talk to ██████████, he got quite a shock to find it was ████████ driving the tractor and beat a hasty retreat.

██████ – 2024 ████████ rang and said she was in ██████████, she had driven in there to pick up new glasses, she said I can see the little white cap on the end of the clothesline was she was sitting on a stool, I get the feeling this may have been the last time ████████ was able to drive off the farm on her own.

██████ said ██████████ said she had to have new glasses, when he took her in there he told the staff that ████████ had full blown dementia and that he was her carer.

██████ was sitting on a seat, she said that she can't tell the difference between the glasses, she described/read signs quite clearly with the old glasses, even commented on seeing the little white cap on the end of a clothesline, her comment was "I don't know why are needed to get new glasses".

I suggested that ████████ go and see her doctor, and be like ████████ and ████████ who asked to speak to the doctor privately, ask ██████████ to leave the room while she speaks to the doctor.

██████ said she had done this but ████████ won't leave, but I said ████████ it is your right to speak to the doctor privately, and he has to obey your wishes.

I asked ████████ who her doctor was; she said it was Dr ██████████ at the ██████████ Medical Practice.

██████ – 2024 ████████ rang, we went through many of the above points, ████████ raising concerns over the handling of the ██████████ Trust superannuation properties by the daughter ██████████.

██████ 2024 there were five phone calls, the first from me, the rest were from ████████.

I asked ████████ how she went with the doctor, she said ██████████ came in, talked to the doctor and would not let ████████ speak.

12<sup>th</sup> and 14<sup>th</sup> of March I rang ████████ to see how she is getting on, ████████ explained how her computer and phone are being monitored, and that mine and sister ██████████ phone numbers are removed from her phone. ████████ said that ████████ had had several phones, some had disappeared, and she wondered if they'd been put up in the ceiling as listening devices,

as when she was talking to us, she had to go outside and be very careful she wasn't overheard.

On the weekend of 16 March, [REDACTED] and [REDACTED] returned from [REDACTED] and called to see us at [REDACTED], [REDACTED] had a copy of a poster that have been put up in the shop at [REDACTED], which stated **Worried About Your Relationship** with a Q code and visit <https://www.police.sa.gov.au/your-safety/dvds>

When [REDACTED] and I opened the site, it gave us options to report on people we thought that were being threatened by domestic violence.

[REDACTED] – 2024 we filled out the online **SA Domestic Violence Disclosure Scheme form and posted it at 12:33 PM.**

[REDACTED] – 2024 [REDACTED] rang, she could only speak for a couple of minutes, [REDACTED] wasn't very far away.

[REDACTED] – 2024 [REDACTED] rang at 10:59 AM. [REDACTED] is getting quite concerned at the demands of [REDACTED], he won't let her go to the craft sessions or anywhere on her own.

I'm getting the feeling that [REDACTED] has been assaulted/threatened as she says she's been threatened by [REDACTED].

I asked [REDACTED] has he got any guns? [REDACTED] said yes they are in cabinets in the shed, and she feels that [REDACTED] wants to shift the guns to the property for 5 km south of [REDACTED] where [REDACTED] and [REDACTED] live.

[REDACTED] is also worried that her grandson [REDACTED], [REDACTED] and [REDACTED] [REDACTED] eldest child, is using a gun/rifle and shooting along the railway line at the back of that property, possible one of [REDACTED], he would barely be 16 years old.

[REDACTED] is also worried that [REDACTED] wants to transfer the Ford Ranger twin cab into [REDACTED] name, she feels he is too young and immature to have the responsibility of a vehicle that size with the peer pressure of modern youth.

**I asked [REDACTED] what she wanted to do, she said she wanted to get away from [REDACTED] from the threats and pressure she has been put under.**

[REDACTED] – 2024 [REDACTED] rang at 4:26 PM. [REDACTED] also mentioned she was being monitored very closely to make sure she was taking tablets that she'd been supposedly prescribed for, [REDACTED] told me she tried to make out she was taking the tablets and then disposed of them when [REDACTED] was not looking.

[REDACTED] – 2024 [REDACTED] rang twice at 10:52 AM and then at 11:30 AM.

I asked [REDACTED] about her wishes of getting away from [REDACTED], I suggested to start sorting things out, arranged in order and packs so when I arrived to pick her up she can bring them to the door and I can load them into the caravan.

I suggested to make sure you have your computer, phone and Seagate hard drive, so they don't get forgotten, as [REDACTED] said they had important information on the that she wanted us to go through.

[REDACTED] – 2004 [REDACTED] rang at 10:01 AM

On one of these calls, [REDACTED] said [REDACTED] had gone to [REDACTED] to see the bank, but in later conversation he said he had lunch with [REDACTED], [REDACTED] could only work out that [REDACTED] had caught the train into Adelaide, she could not see that [REDACTED] coming out to [REDACTED].

[REDACTED] said [REDACTED] never told her very much of where he was going as he never communicated with her.

[REDACTED] – 2024 [REDACTED] rang three times, 11:36 AM, 4:54 PM and 5:04 PM.

[REDACTED] explained she had ordered double lots of [REDACTED] gear for her stomach [REDACTED], and had not unpacked the box as she had it ready to go, [REDACTED] had complained why she had not put it in the cupboard, and [REDACTED] said well I was waiting till I used up what was in the cupboard first, I was stalling him so that I did not have to pack them up when you came to get me.

[REDACTED] – 2024 I travelled to [REDACTED] Tourist Park where [REDACTED] and [REDACTED] arranged for me with a drive-through site, I explained my reason for being there to pick up my sister who was a victim of domestic violence, and needed to depart quickly when there was a window of opportunity to pick [REDACTED] up when [REDACTED] would not be there.

[REDACTED] Tourist Park is a great place and to fill in time many walks were taken looking at the old machinery and memorabilia that had been placed around the park, also very clean, Friendly Park with excellent facilities. The stay there pleasant whilst I awaited the time to pick up [REDACTED].

During the time at the [REDACTED] Tourist Park, I had the chance of about one hour to speak to [REDACTED] asking if she had everything ready before I picked her up.

[REDACTED] – 2024 2:30 PM I left the [REDACTED] Tourist Park and went to [REDACTED], and knocked on the door, and said to [REDACTED] are you ready, she said yes, I said don't forget anything and can you bring all your gear to the door, and I will put it in the caravan.

[REDACTED] indicated that she'd brought all she wanted, I said hop in the car and let's get going.

Whilst we were loading [REDACTED] gear into the car and caravan, I could see through the door and window on the other side the house, [REDACTED] was whipper snipping weeds in the orchard, he had ear muffs on.

We proceeded through [REDACTED], not going [REDACTED] the normal route I would go home, I went home through [REDACTED].

3:44 PM I stopped on the side of the road at [REDACTED] and rang the [REDACTED] police advising them that it wasn't abduction, but a rescue of a person from a Domestic Violence situation.

4:10 PM, a comfort stop at [REDACTED], I rang my sister [REDACTED] and advised her that we had rescued [REDACTED] safely.

We proceeded to [REDACTED] where we stopped at the main road house and [REDACTED] had a cup of tea and a cake and I had a coffee and we had a good chat.

Leaving [REDACTED] we proceeded to [REDACTED] only stopping at [REDACTED] for a comfort stop arriving in [REDACTED] about 6:30 PM.

We unloaded the caravan of [REDACTED] gear and put it in the top bedroom where [REDACTED] set clothes out on the spare bed in neat heaps.

[REDACTED] – 2024 I left [REDACTED] home with [REDACTED], as I had to work the [REDACTED] Transfer Station for the fortnightly rubbish collection.

10.0 1 AM Sgt [REDACTED] rang from [REDACTED] police station, wanted to know where [REDACTED] was, I said she was home, he said could he speak to her, I said that's not possible at this stage as I at the [REDACTED] Transfer Station, he said when will I be home, I said I will be home after lunch, he said can you give me a ring, I said affirmative.

2:48 PM I rang [REDACTED] police, I got a lady on the switchboard, she wanted to know why I wanted to speak to Sgt [REDACTED], I explained what the problem was, she said she would try and contact him as he was out, next thing she came back to me and said I have checked on the computer and that case has been closed.

I thought that's good; there won't be any more trouble now.

[REDACTED] – 2024 I do the rubbish bins it [REDACTED] [REDACTED] and [REDACTED] Lookout, and when I went to do the [REDACTED] Lookout bins I asked [REDACTED] if you'd like to go for a ride and see the views.

She agreed and came, helped change the bins, and we both had a good chat with a couple of tourists that had come from the east coast of New South Wales on what can be seen and done around [REDACTED].

After [REDACTED] and I did the bins, we went inside and had a cup of tea and a coffee and chat with [REDACTED].

Both [REDACTED] with 23 years in the prison system and myself were 20 years in the prison system, we could see [REDACTED] was affected by medication/drugs.

[REDACTED] spoke to [REDACTED] about her so-called full-blown dementia which [REDACTED] claims she's got; [REDACTED] said her specialist was Dr [REDACTED] who is only a practising doctor at the [REDACTED] Medical Practice, **only a geriatrician prescribe dementia**, the doctor can only prescribe cognitive decline.

By the Sunday morning I could see [REDACTED] eyes appeared to be clearer, and I asked her how do you feel, she said I feel a lot better, I can think clearer, [REDACTED] had forgot to bring her medication, and sister [REDACTED] had advised [REDACTED] not to take any more medication.

I asked [REDACTED] when did all this bullying start, she said it started 20 years ago when I had to go to hospital for the big operation from [REDACTED] disease, where I had 18 inches of bowel removed, and [REDACTED] would not look after [REDACTED], [REDACTED] forced [REDACTED] to put [REDACTED] under state care.

Previously when [REDACTED] had a heart problem, the [REDACTED] did nothing to help [REDACTED], but [REDACTED] dad, [REDACTED] managed to pull strings have [REDACTED] to have a heart operation in the Royal Adelaide Hospital. Normally people like [REDACTED] have to go to Melbourne for these operations. [REDACTED] is ever mindful of the only help was that of her father who gave help to [REDACTED] to have the operation, no help from any of the [REDACTED].

[REDACTED] has been living in a house with three other housemates, they've had the same person looking after them for many years, that lady is now retired, and it seemed to be a changing role of people looking after [REDACTED] and the others, and [REDACTED] feels they do not do the job properly, and it is not helped by the fact the other occupants are much younger than [REDACTED].

They have not monitored [REDACTED], a few times [REDACTED] has got out and wandered away to other suburbs and to shopping centres, this is been a worry for [REDACTED].

[REDACTED] explained that there is a [REDACTED] Trust, which she and [REDACTED] are partners, land at [REDACTED] and a house in [REDACTED] have both been put into superannuation trusts, and [REDACTED] feels that [REDACTED] is using his daughter [REDACTED] to transfer this land to [REDACTED] and [REDACTED], she feels if this is not handled correctly, she could be in trouble.

[REDACTED] was worried about a house in [REDACTED], she was frightened if they went to live in it, it had a room with an outside lock on the door and she was frightened she would be locked in there and could not get out.

She also said she was worried about [REDACTED] and the guns that are stored at [REDACTED], she feels [REDACTED] wants to transfer the guns to [REDACTED] and [REDACTED] property which is [REDACTED] south of [REDACTED] towards [REDACTED], where she is not happy that her grandson [REDACTED] has been using a rifle that may have been given to him by [REDACTED] and is shooting along the railway reserve at the back of that property.

[REDACTED] said that [REDACTED] wants to transfer a twin cab Ute to [REDACTED], [REDACTED] feels this is unwise, she thinks he is too young, and with peer pressure these days she feels he will get into trouble, and if having an accident he may kill other people if not himself.

[REDACTED] said she was discouraged from seeing [REDACTED] mother, [REDACTED], who was in a home at [REDACTED], and is about 92 years of age.

I think [REDACTED] did not want them talking, comparing notes, with both of them realising that they've both been bullied by their husbands.

[REDACTED] has claimed that [REDACTED] is a very hard woman, and from what I've seen of the [REDACTED] family, I think [REDACTED] would have given her a hard time, like the time when [REDACTED] was heavily pregnant, he demanded that she come and help draft the sheep in the sheep yards.

[REDACTED] said that she felt [REDACTED] was the only person who understood her, I asked [REDACTED] what she thought would be the best thing to do.

She said I would like to live with [REDACTED], there is the house at [REDACTED], that way I won't be under the influence all these others, it appears the [REDACTED] do not care about their sister/daughter [REDACTED].

I said that sounds like a good idea, I said we can come and visit you and help you if needed.

[REDACTED] also stated the following facts.

- Bruising on arms, also noted by a friends in [REDACTED].
- Refusing to leave so I can discuss things with the doctor, personal women things.
- Standing over me and telling everyone he is my carer as I have full blown dementia.
- Taking phone numbers out of my phone so I can't contact my family.
- Discussing with Dr in my presence that I should be locked up.
- Not allowing me to go anywhere by myself i.e. craft.
- Bully tactics all the time, very manipulative.
- Keeps threatening to have me locked in a cell.
- [REDACTED] said [REDACTED] threatened to hurt her and/or "take her out" if she did not sign the document.
- Got me to sign over \$100,000 at the bank witched I'd saved over the years from working, also a legacy from my mother's estate.
- Bank rang the next day to find out with this was okay, [REDACTED] took the phone call said yes, he did not let me speak to them.
- I rang the bank a few days later to query if it could be reversed and they said it was too late.
- Somehow he is monitoring to everything I have said when he is not there when I've been on the phone to the family.

We discussed taking [REDACTED] to see the doctor tomorrow, having a toxicology blood test done to see what drugs she's been put on, to have them compared to her prescribed medication and see if [REDACTED] has been giving [REDACTED] extra sedative type medication, to be referred to counselling and help with getting a solicitor.

2 PM [REDACTED] come in saying there's two girls in the yard wanting to see [REDACTED].

I went out and asked what they wanted, they said they wanted to see [REDACTED], I said I thought the last I heard she was in Canberra, the said no she not she's here, the police told us.

It was [REDACTED] daughter's, they were [REDACTED] and [REDACTED].

I asked them to leave the property and they wouldn't go, I said this is our property and they had come without invitation, I gave [REDACTED] a shove to get them moving, they left the property.

2:04 PM I came inside and rang the police, requesting that they come and remove these people.

After a period of time a police officer arrived and spoke to us, spoke to [REDACTED] and [REDACTED], and asked to speak to [REDACTED] privately down the yard.

He came back and spoke to us; he had to make a phone call to the [REDACTED] Doctors Surgery so that they could check on [REDACTED] medical history.

I then said that my sister [REDACTED] wanted to speak to him on the phone, he went out for quite a while speaking to [REDACTED].

After a while he got a phone call from the [REDACTED] Dr who said [REDACTED] should be assessed by the ambulance people and that one would be called.

A call was made for the ambulance, and we waited until a call came to the policeman saying the ambulance was leaving [REDACTED] at 18:15 hours and we waited for about half an hour before the ambulance turned up, a female and male ambulance attendants then proceeded to check [REDACTED] out with the police man watching.

On the SAScan there shows two similar callouts, two minutes difference, both show a PR 3, both show [REDACTED], one is [REDACTED] and [REDACTED].

The ambulance arrived about 18:45 hours and they came into the dining room, female ambulance officer, [REDACTED], and a male officer as well as Constable [REDACTED]. [REDACTED] and I

were asked to leave the room, not before I took photos of [REDACTED] and the female ambulance officer and the male ambulance officer.

[REDACTED] and I were sitting in the lounge and after a while they came out and said [REDACTED] was very good and passed all the criteria.

They said that that [REDACTED] had agreed to speak to the girls, I said that's not what [REDACTED] wanted before you spoke to her and the policeman said I will be there with [REDACTED] and the ambulance people when they speak to [REDACTED] and [REDACTED].

The policeman also wanted to know where [REDACTED] phone was, I said it was put away so that she could not be harassed, he said he wanted it.

I suggested and asked that if I handed over the phone before he went to speak to the girls, they claimed that they'd come to see [REDACTED] and had brought her medication, I asked if we could get that medication to [REDACTED], our idea was that when we went to see the doctor in [REDACTED] the next day with [REDACTED], we would find out what the medication was.

Talking to [REDACTED] just before lunch today, she had good clarity and felt very good, I asked her, do you think it's the fact that you are not taking the medication, do you think the medication is causing you to not think well.

As [REDACTED] had been ringing on and off since February, she was desperate to get away from [REDACTED], she said that she had been hiding the medication, pretending to take it.

We discussed with [REDACTED] what she wanted to bring, asked her make sure that she had everything packed and organised that she wanted for when we came to pick up [REDACTED].

When I did go to pick [REDACTED] up, she said she pulled cases/bags from under beds and gathered up gear that she'd identified she wanted to bring with her.

Saturday while I was working the [REDACTED] dump I got a call from Sgt [REDACTED] from [REDACTED] asking where [REDACTED] was, I said she was with us we were looking after her, he said could I speak to it, I'm said I was at the [REDACTED] dump, and when I got home we would ring him, he gave us a phone number [REDACTED].

When I returned home after we had lunch at 2:48 PM I rang that number, got a lady on the switchboard who tried to raise Sgt [REDACTED], she said he was out, she asked what it was about, I explained to her about [REDACTED] being rescued through Domestic Violence and Sgt [REDACTED] wanted to speak to her.

She said I will check on the system, then came back to me and said the matter had been closed..

We let [REDACTED] settle in, and on Sunday morning [REDACTED] came with me to do the bins at [REDACTED] Lookout, she enjoyed the trip as well is talking to holiday people who had been to the west and returning to the east coast of New South Wales.

After we done the cans/bottles we went inside to have a cuppa tea and/or coffee.

I chatted with [REDACTED], noticing her eyes seemed to be much clearer, and I asked how do you feel.

[REDACTED] said I feel much better, I asked [REDACTED] do you think it's the fact that you're not taking any medication, and she said she felt that was the case.

[REDACTED] had been talking about being pressured to sign papers for land transfers and that [REDACTED] had told her the sign or he would hurt her and if she didn't he **would take her out**.

I asked [REDACTED] when this bullying/gaslighting first started, she said 20 odd years ago when I went to hospital and had the operation and had [REDACTED] bag fitted, [REDACTED] did not want to look after our daughter [REDACTED], ([REDACTED] has down syndrome) and forced me to make [REDACTED] a ward of the state, which I then had to manage the money side of it.

This has continued over the years, culminating in being forced under duress to sign over \$100,000 I had in my bank, this included money from my mother's estate, money that I'd invested through my share of the partnership, this is when I first rang [REDACTED] for help.

[REDACTED] is worried about the daughter [REDACTED] and her husband [REDACTED] who have bought the [REDACTED] farm, she feels they are bankrupt and will be sold up, the last time that [REDACTED] and [REDACTED] visited the farm, there was a four bedroom house all with ensuite being built, and it is that the lock-up stage.

The farm has two other houses, a stone house used by [REDACTED] grandparents, a timber framed housing trust style house which was used by [REDACTED] and [REDACTED], [REDACTED] parents and which [REDACTED] and [REDACTED] used up until they went to [REDACTED].

[REDACTED] felt that her \$100,000 was going to help prop that farm up, but her feeling was that it would waste that \$100,000 and they would still lose the farm, and she said [REDACTED] and [REDACTED] for wanting to send their two girls to the [REDACTED] School in [REDACTED], where [REDACTED], [REDACTED] and [REDACTED] went, but not [REDACTED].

[REDACTED] was worried about a property north of [REDACTED] called [REDACTED], that property and the property 4 kilometres south of [REDACTED] where [REDACTED] and [REDACTED] live were bought as superfund farms, and if they weren't dealt right, she felt that she could get into trouble.

She also said that [REDACTED] is a city accountant, and she did not feel that [REDACTED] fully understood that a country accountant for country people is different.

[REDACTED] is also worried that [REDACTED] wants to shift his guns down to property where [REDACTED] and [REDACTED] live, and that their grandson [REDACTED] who is 15 has been using a rifle and shooting along a railway reserve at the back of that property.

[REDACTED] is also concerned that [REDACTED] wants to give one of the vehicles, possibly the Ford twin cab Ute to [REDACTED] when he turns 16, [REDACTED] thinks this is a dangerous thing to do, too big

and powerful a vehicle for a young person, she is frightened what he might do when he comes under peer pressure.

Not only did we want to know what the medication was, our plan was to have [REDACTED] have a blood/toxicology test to see what medication she was on and to compare it, we did not know if [REDACTED] may have been giving [REDACTED] non-prescribed medication of a sedative nature.

Before they went out the policeman wanted to know if [REDACTED] had a computer, she said yes and took it out the bag and showed the policeman.

Next thing they took [REDACTED] out to talk to the girls, then the policeman come back in requesting the computer, [REDACTED] wanted it.

I said I don't think that is a good idea because [REDACTED] told me that that's got stuff on that is very important to her regards finances.

No it has got to go out to [REDACTED] the policeman said.

Next thing I went out and [REDACTED] and [REDACTED] are hugging and browbeating [REDACTED].

Next thing the bombshell dropped, the ambulance woman said that [REDACTED] has got to go to the [REDACTED] hospital; I said why you just said there's nothing wrong with her.

She made up some story that she had a high temperature and she had a urinary tract infection and she has to go to the hospital to be assessed.

I went back in and told [REDACTED] come here, as I was telling the ambulance officers and the policeman that I did not want [REDACTED] to leave, we had her booked in to see a doctor tomorrow.

They would not back down, and they proceeded to put [REDACTED] on a gurney and strap her down.

Next thing the policeman come to me asking for a brown bag and shoes for [REDACTED] as she wanted them, we found them and gave them to the policeman.

There seem to be a lot going on around the other side of the ambulance so I thought I'd go and have a look, [REDACTED] was up inside the ambulance holding [REDACTED] hand browbeating her and next thing I noticed [REDACTED] was holding the brown bag and the computer, not the red shoes.

I said she's not taking them they belong to [REDACTED], and I went to grab them and I was forced off by the policeman.

I challenged [REDACTED] for having the computer and brown bag and next thing I saw [REDACTED] give the bag and the computer to the [REDACTED] the woman ambulance officer who put them in the ambulance.

I argued with the policeman that [REDACTED] was going away to be committed, he said no she is going to [REDACTED] to be assessed and she was not going back to [REDACTED] and I was not to drive in but I could check on [REDACTED] tomorrow.

Next thing the ambulance drove north down the street to the first corner and turn right and as they were driving off the white Hyundai people mover followed them very closely, I expected them to do a turn around the block and go up the hill to [REDACTED], they never did.

Once out of sight, I don't know if the ambulance stopped and gave the computer and brown bag back to [REDACTED] and [REDACTED].

The policeman got in his car went down the street in a northerly direction before turning around and coming back down the street and turning right up the hill to go to [REDACTED].

The policeman's name is Constable [REDACTED] and his No is [REDACTED] and he comes from [REDACTED], why was he going up the hill towards [REDACTED] way, was he going to pull me over if I went into [REDACTED] the night.

I get the feeling that Constable [REDACTED] the policeman and the two ambulance officers were not telling me the truth, I have a gut feeling that they've taken [REDACTED] a way to be locked up/committed.

I hope I am wrong.

I then went inside, and rang [REDACTED] 7:52 PM, we received a text showing that the SAAS had left at 18:15 hours, [REDACTED] PR 3 which meant it arrived in [REDACTED] approximately 18:45 hours.

[REDACTED], the other ambulance officer and Constable [REDACTED] all said that [REDACTED] was going to [REDACTED] hospital to be assessed; she was not going back to [REDACTED].

[REDACTED] scrolled through the SAA's app to find a transfer at 20:00 hours for a [REDACTED] PR 8 [REDACTED] to Adelaide.

The five minutes I was outside looking for the ambulance to go up the hill, plus 7:52 PM the time I rang [REDACTED], gives a time of 13 minutes until 8 o'clock, there is no way that ambulance left [REDACTED] and went to any hospital in 13 minutes, [REDACTED] is 40 km away, then it's another 40 km to [REDACTED], there is no way they went to [REDACTED] Hospital to have [REDACTED] checked in that time.

To me it means both the Ambulance Officers and Constable [REDACTED] lied to us, [REDACTED] never went to [REDACTED] hospital, and as it turns out she is living back in [REDACTED].

We have now found out that [REDACTED] is living with [REDACTED], apparently the ambulance took [REDACTED] to [REDACTED] house in Adelaide, where [REDACTED] now has control of the computer and the hard drive.

The night that [REDACTED] was taken in the ambulance, [REDACTED] and [REDACTED] were only interested in the computer, the bag and the phone.

Since then they have been harassing us wanting [REDACTED] bedding, pillows and a whole list of other things, claiming if we thought so much of our sister we should give them to them, that's not going to happen until we can talk to [REDACTED] freely on her own phone where she is not being badgered and we get [REDACTED] hard drive.

There were 11hours of phone calls between [REDACTED] and myself, 7 of those hours were [REDACTED] asking for help and explaining the horrors she was being put through by [REDACTED].

**Early dementia Geriatrician to verify, Cant be doctor, he can only do cognitive impairment.**

**I feel [REDACTED] has bluffed the Doctor or the Doctor is in collusion.....**





15 – 05 – 2024. I called into [REDACTED] to see [REDACTED] and [REDACTED].

[REDACTED] told me that [REDACTED] had been taken by the ambulance to Adelaide to [REDACTED] [REDACTED] house, and then she was returned to [REDACTED], [REDACTED] and [REDACTED] farm house which Constable [REDACTED] promised me that she would never be going back to [REDACTED] to live with [REDACTED], he had a body cam on and I'm sure that if it hasn't been erased it will prove that he lied to me.

This proves the St John's Ambulance people lied to me, they said she was going to [REDACTED] [REDACTED] Hospital to be assessed for the medical reasons, this never happened as it can be proved by the SAAS timeline on the SA SCAN app which we did a screen capture.

Leaving our place about 7:50 PM, and the ambulance showing a timeline of 20:00 hours, it could not have gone to [REDACTED] or [REDACTED] Hospital in 10 minutes, as both are over 40 km away, the ambulance when it left [REDACTED] went straight to Adelaide.

[REDACTED] told me that [REDACTED] made her apologise to him for what happened before you let [REDACTED] come and see her.

[REDACTED] brought [REDACTED] to visit [REDACTED] and [REDACTED], [REDACTED] would not let [REDACTED] speak to them on her own.

[REDACTED] could see that [REDACTED] was drugged up, and much to [REDACTED] displeasure, [REDACTED] got her to take a photograph of [REDACTED] and herself.

As you can see by the above photographs, there is a big difference between the one on the Sunday in [REDACTED] to the one taken at [REDACTED], you can tell the faces are entirely different due to the drugs that she's been forced to take, apparently [REDACTED] lines the medication up on the table and stands over [REDACTED] and forces/makes her take them.

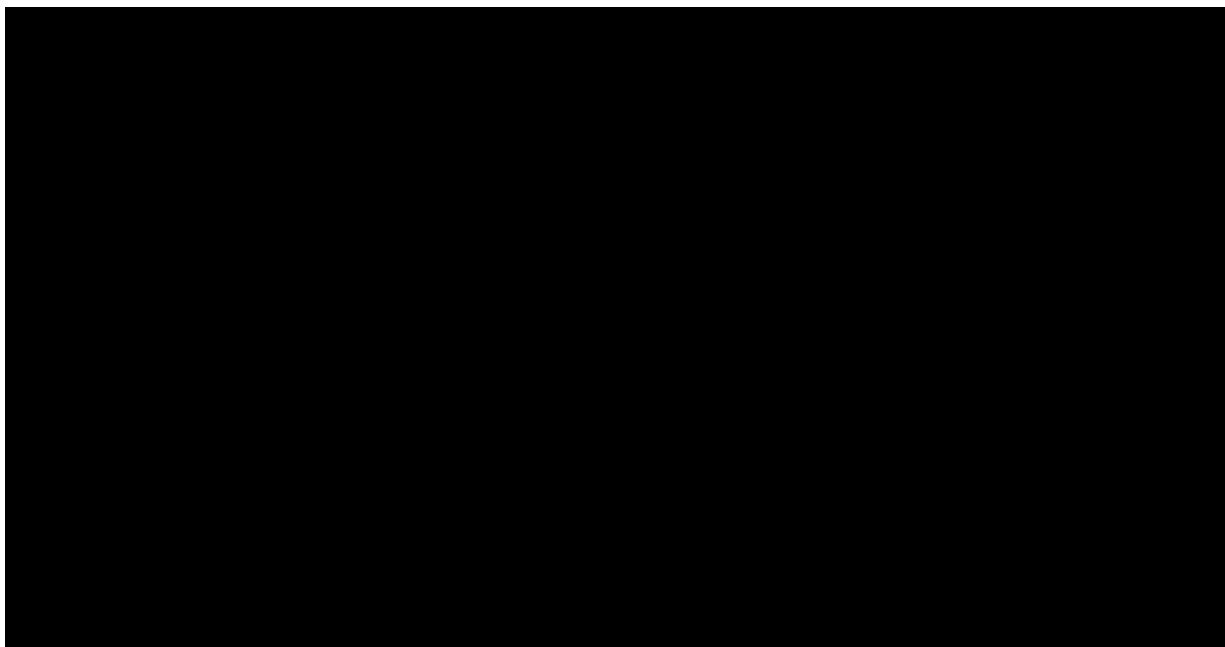
As far as I'm concerned, the Doctor [REDACTED] at the [REDACTED] Medical Practice is complicit in the drugging up of [REDACTED], he is not a **geriatrician**, he can't diagnose [REDACTED] with full-blown dementia, he can only diagnose cognitive decline.

[REDACTED] told me that when my mother who had dementia, she had walked out the [REDACTED] Road near [REDACTED], and when they got her back to the hospital, [REDACTED] told [REDACTED] they gave my mother ½ a tablet which stopped her from walking out again (made her a Zombie).

At that time [REDACTED] was the President of the [REDACTED] Hospital Board, and he would have had access to all this information, I am wondering if it's the same drug he is administering to [REDACTED]?

Apparently [REDACTED] has installed a gate alarm, this rings a loud bell in the house when anyone comes through the gate, also it means [REDACTED] if she walks around the fence of the 20 acres, she can't go through the gate without setting the alarm off, it is the only gate way on the property.

If [REDACTED] has to go anywhere, he takes [REDACTED] to [REDACTED] place and leaves her there where she can't go anywhere or see anyone.



[REDACTED] says he has information that the Australian Tax Office would not be happy with what [REDACTED] has done, I think [REDACTED] **should be asked to write a letter to the ATO explaining his concerns, it can't affect [REDACTED] now, but it might help open the window onto the financial affairs of [REDACTED] and [REDACTED] the family accountant.**

[REDACTED] said it's all been worked out, [REDACTED] gets the property south of [REDACTED] and [REDACTED], and [REDACTED] will get the homeplace, the \$100,000 from [REDACTED] account has gone to [REDACTED] to save the [REDACTED] farm, and [REDACTED] thought when we were speaking with her that a house in [REDACTED] would be sold and the proceeds go to [REDACTED] and [REDACTED] farm, [REDACTED] is frightened she might be locked in a room of the house they have in [REDACTED], it has an outside lock on a door on one of the rooms.

████ said █████ is now been diagnosed with diabetes.

I asked our Nurse friend █████, a very experienced/highly trained nurse, what would be the name of the half pill given to my mother to quieten her down (make like a zombie), she said it could be Risperidone or Quetiapine, I have googled and it and looked at some of the side-effects of these drugs.

**Side-effects of observed/seen in █████.**

Diabetes, cognitive dysfunction, increases risk of mortality, tardive dyskinesia, high triglycerides, and weight gain, having to get new glasses, difficulty in concentration, anxiety, increase in urine (may be the cause of Coralie's so-called urinary infection by ambulance officer Jess).

My observations of █████ from the first phone call last year until the time she was removed from █████, I'll feel some of those side-effects were obvious in █████.

### **Summary.**

████ bullying/domestic violence started back 20 odd years ago when she went to hospital to have her bowel operation, █████ forced █████ to sign █████ over as a ward of the state, to which █████ for years managed the financial side of █████ institutionalisation.

████ was bullied/forced to hand over the financial affairs to daughter █████, █████ won't have █████ on his property, and █████ has taken over the financial considerations of █████.

████ is worried about the financial side of the █████ Trust, this is where properties around █████ had been bought and put into a superannuation trust, and █████ felt she would be in trouble if they were just handed over to the daughters.

████ is also worried about █████, the lady looking after her has retired and the new people do not have the same dedication as well as the other residents being of a much lower age than █████.

████ would like to live with █████ and look after her; she is the only one that has any caring/feelings for █████ out of the █████ family.

████ said █████ has a government job which sends all over Australia, feels with the job and being a partner of the farm, it is too much for █████ to look after █████ properly.

████ had much admiration for her father █████, he was the only one that helped get █████ to have her open heart operation in the Royal Adelaide Hospital, the █████ weren't interested in helping █████, I get the feeling that they felt █████ was a burden and did not like her.

██████ said ██████ had been organising her medication, she tried to juggle it so it appeared she taken the tablets when in fact should put them in the bin, she knew they were not doing her any good.

██████ 2023. Monday, 11 December 2023 was the first phone call I had from ██████ for a long time, she was asking for help, this is when she started explaining to me some of the problems she had with ██████, her husband, who had been bullying/threatening her, had just forced her to sign over her private bank savings, which included money going back to when she first started working at ██████ store in ██████, as well as money that came from our parents estate plus interest that had accrued over the years. ██████ felt this money was to go towards the farm at ██████ to save it from going bankrupt. ██████ wanted this money to help ██████, she felt that ██████ was not getting any benefits from the ██████ dynasty.

██████ told me that she had to be very strict with the farm money, if a new tractor was bought, an old one had to be sold and no more until the last one had been paid for, ██████ ██████ would have been bankrupt years ago if it hadn't been for ██████ tight fiscal management.

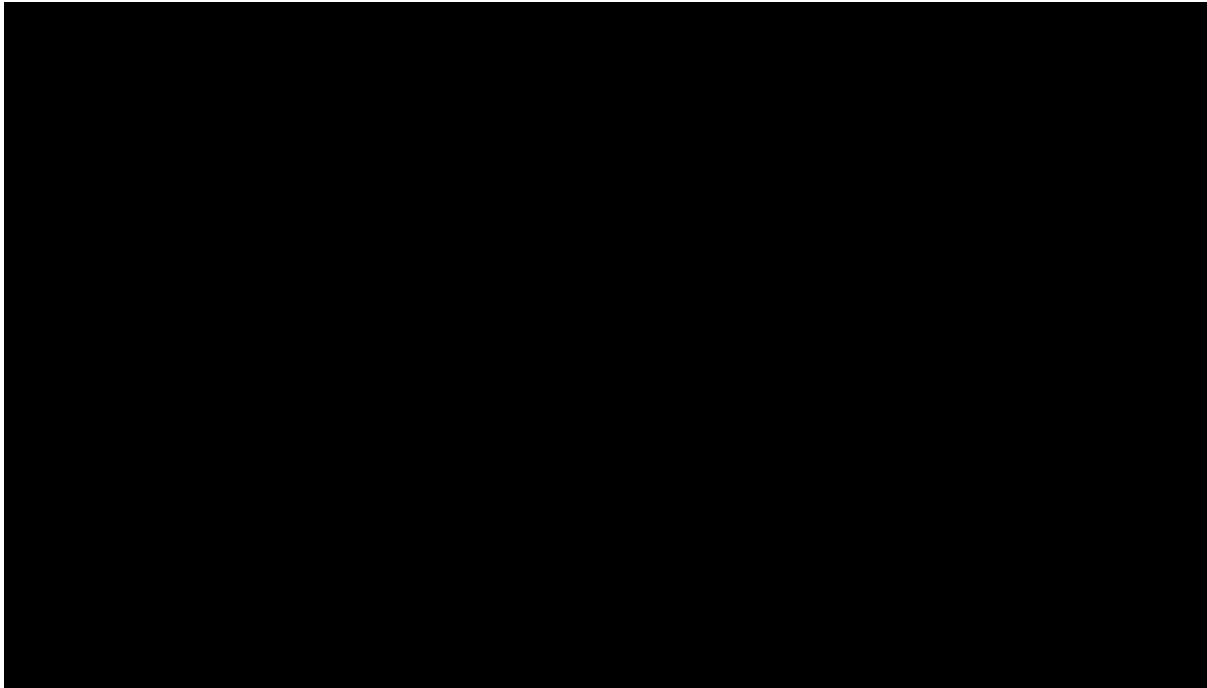
██████ also said that she used to do tractor driving for the seeding, while ██████ ██████ would be ██████ Hospital Board Meeting in ██████ and would often be coming home very late after these meetings, sometimes she had driven down the road after the meeting would have finished to see where ██████ was, and then returned home and go to bed, eventually ██████ would arrive home. ██████ didn't know whether he was dilly dallying around with any other women.

Since being at ██████ ██████ has had a valiant refurbished and re-sprayed, and often spends many hours chatting up a lady at the crash repair business (who is much younger than ██████), that works there, often if ██████ is in the car, ██████ ██████ tells ██████ to sit in the car and wait till I come back, this can be up to over an hour later.

██████ feels that the lady is after ██████ money, and once she has that she'd drop him.

██████ has also been discouraged from seeing ██████ mother ██████, who is 92 and in an old folks home ██████, knowing the ██████, I think ██████ was bullied by her husband ██████.

I think it's a good time for ██████ to write a letter to the ATO's explaining what he knows about ██████ legal matters concerning the ██████ Trust.



Speaking with [REDACTED], after she told me that [REDACTED] had threatened her to sign papers, if she didn't he would hurt her and would "take me out".

This is when I asked [REDACTED] did [REDACTED] have guns on the property at [REDACTED], and [REDACTED] said yes, there in a gun safe in the shed.

This is when I realise we had to get [REDACTED] out of [REDACTED], before [REDACTED] did anything stupid.

[REDACTED] was also worried about her grandson [REDACTED], who not being 16, was using a rifle possibly supplied by [REDACTED] and shooting along the railway reserve at the back of [REDACTED] and [REDACTED] property, [REDACTED].

[REDACTED] is not happy that [REDACTED] was to hand over a twin cab Ute to [REDACTED] ready for his 16<sup>th</sup> birthday, [REDACTED] thinks [REDACTED] is too young to have the responsibility of that vehicle.

Friday, 5 April, I picked [REDACTED] and her gear up from [REDACTED] and brought her to [REDACTED].

Sunday the 7th, two daughters [REDACTED] and [REDACTED] turned up wanting to see [REDACTED], they were ordered off the property and I called the police to have them removed.

Constable [REDACTED] from [REDACTED] came, interviewed [REDACTED], [REDACTED] spoke to him over the phone for a long time, he spoke to me and then he spoke to the two daughters.

Obviously Constable [REDACTED] wasn't interested in the domestic violence report, he believed the spin the daughters put over, he contacted the doctor who asks that [REDACTED] be assessed by St John ambulance, then they lied and got [REDACTED] out onto the road to see the daughters, lied to us again saying she was going to the [REDACTED] Hospital for

medical attention, when within fact they took [REDACTED] straight to Adelaide to [REDACTED] [REDACTED] place in Adelaide including [REDACTED] laptop, phone and Brown bag.

I was forced by Constable [REDACTED] to hand over [REDACTED] laptop, phone and brown bag, there was no hint of anything else of [REDACTED] property wanted. They definitely did not want us to find out what was on the laptop, which was [REDACTED] wish we go through it to see what [REDACTED] and [REDACTED] have been doing.

Since then [REDACTED] has been returned to [REDACTED] care, and when he has to go off and do business, he takes to [REDACTED] place, at [REDACTED] [REDACTED], he has in an alarmed gate, which alerts [REDACTED] if a vehicle comes in or if [REDACTED] leaves the property. This means [REDACTED] can be assaulted/harmed and no one can see what's going on as she is needed/cohursed to sign papers for further property transfers.

[REDACTED] has been to seen friends [REDACTED] and [REDACTED], [REDACTED] brought [REDACTED], but they could not speak to [REDACTED] on her own, though they did get a photograph of her, [REDACTED] does not look well and badly needs a haircut.

Facebook sent email notifying removal of article stolen from property [REDACTED] does not meet their standards, it offends perpetrators.

### **What is a compulsory reporting for potential abuse situations?**

Mandatory reporting is when the law requires you to report known or suspected cases of abuse and neglect. It mainly relates to children, but can also relate to adults if the person involved is living in a residential service.

What are 8 categories of concern in the mandatory reporter guide?

- Physical Abuse. You suspect a non-accidental injury or physical harm to a child/young person may have been caused by a parent/carer or other adult household member. ...
- Neglect. ...
- Sexual Abuse. ...
- Psychological Harm. ...
- Danger to Self or Others. ...
- Relinquishing Care. ...
- Carer Concern. ...
- Unborn Child.

### Coercive control

Coercive control is often a significant part of a victim-survivor's experience of family and domestic violence.

It describes someone's use of a pattern of abusive behaviours against another person over time, with the effect of establishing and maintaining power and dominance over them.

Abusive behaviours that perpetrators can use as part of their pattern of abuse include:

- physical abuse (including sexual abuse)
- monitoring a victim-survivor's actions
- restricting a victim-survivors freedom or independence
- social abuse
- using threats and intimidation
- emotional or psychological abuse (including spiritual and religious abuse)
- financial abuse
- sexual coercion
- reproductive coercion
- lateral violence
- systems abuse
- technology-facilitated abuse
- animal abuse.

## ROYAL COMMISSION INTO DOMESTIC, FAMILY AND SEXUAL VIOLENCE

My sister [REDACTED] has suffered domestic violence from her husband [REDACTED] for many years, starting when she had Chrome's disease and a large portion of bowel removed, she now has a plate and a bag on the stomach.

When she was in hospital and recovering from that operation she was forced to put their autistic child [REDACTED] into state care.

Property involves farms around [REDACTED], houses in [REDACTED] and [REDACTED], and when [REDACTED] rang me in December 2023, she informed that she been forced sign over her life savings, (\$100,000) this includes a legacy from our mother's estate, which [REDACTED] was keeping to help [REDACTED].

[REDACTED] told me that [REDACTED] had been making her take medication, which he told everyone she had full-blown dementia.

We rescued [REDACTED] from [REDACTED], and it was easy to see that she was effected by some type of drug.

We have since found out that [REDACTED] was aware that our mother had been given a drug which we feel brought on her full-blown dementia and he is working with a doctor at [REDACTED].

We are disappointed that the police and ambulance came to our place and took [REDACTED] away, they said she was going to [REDACTED] Hospital, she never did, she went to a daughter's place in Adelaide, and has since been returned to [REDACTED] under the control of [REDACTED].

From what we are told she been forced to take medication, and since returning to [REDACTED], she's diagnosed with diabetes, has been admitted to the Royal Adelaide Hospital with collapsed kidneys and lost 15 kg of weight.

When she left [REDACTED] she was healthy though she had cognitive traits.

I feel the treatment that [REDACTED] has received warrants exposing as not only her husband [REDACTED] been part of the domestic violence, her daughters [REDACTED] and [REDACTED] have been part of the asset stripping and control of my sister.

[REDACTED] has put an alarm system on the gate of the property at [REDACTED], which alerts him if anyone is coming to see [REDACTED], plus if [REDACTED] wanders off he knows.

I am including all my notes, conversations, record of all phone calls, the times and who did the calls, for your information.
